Triathlon WA is a non-profit organisation and is affiliated to the national governing body, Triathlon Australia. A sport once seen as extreme is now accessible to everyone with introductory distances for novice competitors right through to the Iron distance.

The Association focuses on encouraging a strong club membership structure which allows WA members to train within a community of like-minded people. A key focus for Triathlon WA is to promote and capitalise on the health and lifestyle benefits that come from taking part in triathlon – the physical, social and mental benefits.




PRESIDENT'S REPORT

This season has been another challenging and rewarding one where we once again faced impacts due to the COVID-19 pandemic. However, I believe TWA has performed well and delivered for our awesome triathlon community this season. This is my final year as a Board Member and as President and will therefore be my last annual report.

From a membership perspective, we unfortunately saw a marginal decrease in members, but a lower decline than the national average. The main challenge the sport faces in this regard is clearly communicating the value proposition of a Triathlon Australia membership, an area I hope the national body puts more emphasis on.

Earlier this year we saw the successful delivery of the inaugural SunSmart Busselton 100. It was a fantastic weekend of triathlon with perfect racing conditions for the long course on Saturday. The race has been years in the planning and has been a topic of discussion at a Board level for the four (4) years I have been involved. It was brilliant to see the event delivered successfully and with increased participation numbers. The event is wholly owned and run by TWA, meaning that any profits from the event get reinvested back into supporting the triathlon community in WA. So I would encourage you all to keep supporting the SunSmart Busselton Festival of Triathlon and the SunSmart Busselton 100 in years to come.

From a financial perspective, the association continues to go from strength to strength. When I joined the Board four (4) years ago, financial stability and sustainability were key concerns of mine. The Association reported a \$67,000 loss that year and reserves of \$400,000 were dwindling. It is pleasing to see that we are managing our finances well and are in an enviable financial position compared to other Triathlon State Associations. We are pleased to present this year's financial reports having in excess of \$900,000 in reserves.

Conversations continue with Triathlon Australia around their new governance model. The model is aimed at centralising governance, finances and resourcing for all States under a "Future Operating Model". The TWA Board still does not believe that adopting the model is in the best interests of our members. There has been no tangible evidence provided to date that the model is delivering on the promises of increased membership and more efficient State and National operations. We will, however, continue to keep an open mind and work collaboratively with Triathlon Australia and other State Associations around the country.

PRESIDENT'S REPORT CONTINUED

I would like to personally thank my fellow TWA Board Members, Brenden Koh (Vice President/Audit and Risk Committee Member), Lauren McGregor (Treasurer/Audit and Risk Committee Member), John McCann, Ben King, Sophie Row, Henrietta Farrell, Morgan Marsh and Ashlee Morgan for their valuable contributions and leadership over the last year.

I would also like to thank all Board Sub-Committee Members on the Audit and Risk Committee, Nominations Committee, Women in Triathlon Committee and Technical Reference Panel for their advice and contributions throughout the year. Thanks also to our Life Members for providing their guidance to the Association.

On behalf of the Board, I would like to extend our sincere gratitude to our incredible Executive Director, Ashleigh Apps. Ash continues to play a key role in the successes of the organisation and should be recognised for the incredible work she does. I'd like to welcome Glenn Te Raki to the position of Executive Director whilst Ash is on maternity leave. Glenn has big shoes to fill, but I'm sure he'll do a great job. We welcomed new staff to the organisation over the year with Emily Ekert, Rebecca Bury and Mike Gee working alongside Tarquin Bateman and Cathy Hoare. I would also like to thank them for their hard work and efforts throughout the year.

A massive thank you to the hundreds of volunteers involved in all areas of our sport in WA, the sport would be far worse off without you all. We appreciate and commend the sacrifices you make so that we can enjoy what the sport has to offer.

Lastly, as I step down from the Board and the President role, I'd like to thank everyone for their support over the years. I've personally learned a lot over the last four (4) years, and I'm very thankful for the opportunity I was given to be on the Board and to lead the sport in WA. TWA is in a great place and I hope it continues to improve year on year. The incumbent Board Members are fantastic and I have no doubt they will work to continuously improve the sport for everyone involved. Thank you.

EXECUTIVE DIRECTOR'S REPORT

2021/2022 was a year of considerable change and opportunity for Triathlon Western Australia. With the dissolution of the IRONMAN contract for our marquee event, we were able to rebrand the SunSmart Busselton Festival of Triathlon and launch the SunSmart Busselton 100. The support of the WA triathlon community, who embraced this change, was integral to the success of this inaugural event.

Triathlon WA club administrators, coaches, race directors and volunteers have faced many unforeseen challenges over the last few years. However, they have worked tirelessly to continue to provide programs and other opportunities to triathletes of all ages and levels.

The operational focus has centred on efficiency, communication and achieving our strategic goals. Building club resources, reducing administration processes and ensuring clubs are supported with critical services was (and will continue to be) the core focus. Triathlon WA continued to provide valuable experiences for our members, and high quality race opportunities to engage the wider public.

The new partnership with Outside the Locker Room and Star Physio will assist clubs and coaches with mental health and physical health services through engagement and education.

It was pleasing to see participation numbers increase across racing starts in WA, and we will be working with race directors and clubs to continue this trend into future years.

We welcomed three (3) new staff members to Triathlon WA over the season, Rebecca Bury (Commercial Operations Manager), Emily Ekert (Membership and Marketing Manager) and Mike Gee (Athlete and Coach Pathway Manager). All of them hit the ground running within their respective areas. Thanks goes out to Cathy Hoare (Technical and Sanctioning Officer) who continues to support our race directors and technical team, and Tarquin Bateman who provides administration and marketing support to the organisation. It's a small, yet passionate team who works tirelessly behind the scenes.

Our sport is supported by a number of partners who invest in the growth and development of Triathlon WA. Special thank you to DLGSC, Heathway and Lotterywest, Tourism WA, the City of Busselton, and the City of Rockingham. Along with all of our corporate partners who support our organisation and events.

We thank our community of clubs, coaches, officials, committees, staff and volunteers for their excellent work. Thank you to the volunteers on the Triathlon WA Board, led by President Steve Lyon, who provide their time, expertise and support to drive the strategy and long-term direction for the sport. We are again looking forward with optimism and we wish you all the best for a successful and prosperous 2022/23 season.

MEMBERSHIP & CLUBS REPORT

Following a comprehensive membership review to address trends of declining membership over recent years, Triathlon Australia introduced a new membership platform in 2021 along with a restructured membership offering for the 2021/22 season. Due to the change in platforms, auto-renewal was not possible, so clubs worked tirelessly to ensure their members registered for the season using the new platform. Clubs also adapted quickly to GoMembership and the new membership structure which made the transition more seamless than anticipated.

Despite a slight increase in memberships between the two (2) preceding seasons, Triathlon WA saw a 6% reduction in memberships in 2021/22. Males accounted for 58% of the membership and females made up 42%. Similar to previous years, the majority of WA members were aged between 30 and 54 (62%). Surprisingly, 30% of the membership consisted of new members (never held a Triathlon Australia membership previously) which indicates the sport was exposed to a new market.

As part of the 2021/22 membership offering, Triathlon WA facilitated member education sessions on several topics. These included multiple nutrition seminars, an injury management workshop, considerations for training as a female athlete, basic bike mechanics and a swimming skills session for Premium Members. Triathlon WA is excited to provide further education sessions to our members next season.

This season we welcomed back our 21 previously affiliated clubs plus one more, Western Australia Police Triathlon Club (WAPTC). Our club system covers the Perth metropolitan area and expands into the regional hubs of Bunbury, Busselton, Albany, Mandurah, Kalgoorlie, and Esperance. Eight (8) affiliated WA clubs experienced a growth in membership in 2021/22 which was fantastic to see.

At the beginning of the season, Triathlon WA conducted a Club Development Project which involved a club audit. The project resulted in a detailed gap analysis and the establishment of resources to assist Club Committees with managing and developing their clubs.

A Club Development Toolkit was distributed to clubs to aid in a number of areas including strategic and financial planning, marketing and policies and procedures.


In line with the Club Development Project, Triathlon WA started implementing a workshop series that targeted the key areas identified in the gap analysis. Volunteer management and governance workshops were held during the season to develop the skills of Club Committee members. Triathlon WA will look to administer further workshops next season.

Thanks to our partnership with SunSmart, six (6) clubs were awarded a funding grant of \$2,000 to enact initiatives that increase awareness of the SunSmart message. The successful applicants were Armadale, EFS, Mandurah, Perth, WA Police, and Rockingham Triathlon Clubs. These clubs were awarded the funding as they were able to demonstrate how they currently promote SunSmart messaging, the policies that have been implemented into their club activities and an effective initiative the club would enact with the grant. The funding was spent on SunSmart merchandise, club marquees and other SunSmart initiatives.

The Triathlon WA Interclub Series, now in its second year, consisted of 13 events held across WA including multiple regional locations such as Corrigin, Esperance and Kalgoorlie. Triathlon WA members participated in the Series nearly 1,500 times throughout the year with the most popular events being the SunSmart Busselton 100 and the Giant Mandurah State Interclubs (see the figures on page 25). The winning club in each Conference was awarded \$250, with the overall winning club being awarded an additional \$500. The winners were:

- North Metropolitan Conference Champions – North Coast TC
- South Metropolitan Conference Champions – Mandurah TC
- Regional Conference Champions – Bunbury TC
- Overall Champions – North Coast TC

Triathlon WA looks forward to building memberships and supporting clubs again in season 2022/23.

PARTICIPATION & ENGAGEMENT REPORT

Triathlon WA conducted 71 visits to 22 different schools throughout the 2021/22 season to deliver the Junior TRYstars program and another two (2) schools ran teacher-delivered programs. Eight (8) of these programs were funded through Sporting Schools and 11 schools were in regional areas. A total of 1,903 students engaged in the schools' programs, creating 4,772 individual exposures to the sport (number of visits multiplied by the number of students in each session). These programs were a great way to expose primary school students to the sport and encourage them to continue participating through their local club.

The SunSmart Kids Triathlon Series was a successful participation initiative held in 2021/22 by Triathlon WA clubs. The Series, which was funded and supported by Triathlon WA, encouraged host clubs to create a fun, safe, friendly, and enjoyable race environment for kids aged 7-15 years. The aim of the Series was to increase participation in the sport and inspire children to lead active and healthy lifestyles. The races were also an opportunity for Triathlon WA and clubs to raise awareness and increase positive attitudes towards the SunSmart message and healthy participation.

12 SunSmart Kids Triathlons featured on the 2021/22 season calendar with nearly 700 kids participating in the Series. Four (4) of these events were held in regional towns - Kalgoorlie, Mandurah, Corrigin and Busselton. Every child received a swim cap, a finisher medal and a colouring-in sheet again this year as the focus was on participation over performance. Long-sleeved SunSmart rashies were also given to the clubs to be distributed amongst participants.

Now in its second year, the SunSmart Time to Tri program for beginners was facilitated by Triathlon WA. Clubs were able to apply for funding and other support to run an 8-week triathlon program aimed at new participants in the sport. Five (5) programs were held this year including two (2) Women Only and one (1) Men Only programs, engaging over 80 participants.

As part of the program, Triathlon WA hosted a Beginners Workshop and a Nutrition Webinar for the participants. They all received a water bottle and a free Triathlon Australia 8-week trial membership as part of their registration.

In addition to the SunSmart Time to Tri novice programs, Triathlon WA partnered with recreation centres and clubs to deliver the indoor beginners program, TriActive. This 6-week program targeted adults starting or returning to regular physical activity and those looking to take on a new challenge.


Three (3) TriActive courses were held throughout the 2021/22 season including one (1) in Esperance. The two (2) metro programs sold out and all participants raced in a beginner-friendly event on the TWA calendar.

Three (3) clubs facilitated TRYstars programs during the 2021/22 season. The participation-focused programs ran for 6-8 weeks and were aimed at juniors aged 5-15 years who were relatively new to the sport. North Coast, Rockingham and Busselton Triathlon Clubs hosted these programs in the lead up to their SunSmart Kids Triathlon events to ensure the juniors were prepared and had some experience in each discipline. The aim of the program was to encourage the children to lead an active and healthy lifestyle, with a focus on the SunSmart message.

Triathlon WA once again facilitated the Come & Tri Week initiative in 2022 for the second year in a row. The aim of Come & Tri Week was to attract new participants to the sport of triathlon across the State. Clubs were encouraged to participate in the initiative by opening their regular training sessions or hosting a specific session for beginners, so they had the opportunity to experience the sport in a safe, welcoming and fun environment. Triathlon WA supported the clubs by providing marketing collateral, promoting the event and taking registrations.

Seven (7) clubs hosted 22 beginner-friendly sessions over Come & Tri Week in January 2022, resulting in 44 registrations. The sessions were a mix of swimming, cycling and running skills with one (1) club hosting a 'Splash and Dash' event. Overall, the initiative was quite successful with some participants joining Triathlon WA as members following the trial membership period. Several areas for improvement were identified which will be crucial when planning the event again next season.

Triathlon WA hosted a Women in Triathlon information session at the Season Launch in 2021. 30 females attended to listen to topics presented by guest speakers including women's pelvic health and how to change a tyre. Additionally, in the lead up to the Every Woman Triathlon, Triathlon WA presented a Women's Beginners Seminar which involved a female coach, athlete and Technical Official sharing their triathlon journey and providing tips for women new to the sport.





DEVELOPMENT PROGRAM REPORT

The focus of the Triathlon WA Athlete Pathway Program in 2021/22 was draft legal races and skills sessions for the athletes in the program. Importance was placed on these key areas to give WA juniors the best opportunity to develop in race situations. We had 33 junior athletes register for the program this year.

The education, race and skill sessions during the program included:

- A transition session
- An open water skills session
- Super sprints & a mixed relay at Champion Lakes
- A mixed relay at Ern Halliday Recreation Camp
- Super sprints & a mixed relay at Champion Lakes in March
- Three webinars on health and nutrition
- Three webinars on sports psychology

COVID-19 continued to limit our travel interstate during the 2021/22 season. However, in April 2022 11 WA athletes relished the opportunity to travel to Runaway Bay to compete against the other States at the Australian Super Sprint Championship. Tommaso Puccini placed second in the Male Junior A Final and Indie Arbuckle crossed the finish line in third place in the Female Junior A Final. A total of eight (8) WA athletes made the A Finals.

Rhianna Hepburn continued the fantastic trend of results achieved by WA athletes at the Werribee South Beach Triathlon when she was crowned Oceania Triathlon Junior Champion. Madison Toovey placed ninth (9th) and Tommaso Puccini placed 22nd at the same event. The trio also placed fifth (5th) in the team relay event.

Congratulations to Rhianna Hepburn on her win in Werribee and on being awarded Triathlon WA Pathway Athlete of the Year.

- Coaches round table after the Foreshore Rockingham race on athlete induction
- Coaches round table on athletes returning from COVID-19

Alex Barron from Armadale Triathlon Club was awarded the Community Coach of the Year for his outstanding work in setting up and developing the community around the club.

TECHNICAL OFFICIAL REPORT

While the past season saw its challenges as we continued to work through COVID-19 restrictions, WA was fortunate enough to host majority of our events. Triathlon WA provided Technical teams at 39 events over the season ranging from International Events (GWM IRONMAN WA) to races supported by our Affiliated Clubs. We invested in providing additional Officials at club events to work with the volunteers around athlete safety and fairness. These events included:

- Corrigin Triathlon
- Rockingham Spring Triathlon
- SunSmart Kids Triathlon Armadale
- Kalgoorlie Women's Triathlon
- Bunbury Women's Triathlon
- Bunbury Triathlon Club Race

Over the season, 172 officiating positions were filled by our TWA Technical Officials

This season saw 51 accredited Officials in WA. While this number was a marginal decrease on previous years, we are pleased to provide quality officiating and support for our events in WA.

We would like to acknowledge the following Officials and their achievements during the year:

- Trevor Forward officiated at 13 events. We would like to personally thank Trevor for his dedication to the officiating program.
- Catherine LeGrand and Mike Heck were awarded the prestigious Steve Barrie Award for their support of the technical program. Mike and Catherine completed the Level 1 Technical Official Course in October 2021. Despite being new to the program, they were actively participating as Officials and both were deserving winners of this award.
- Frank Stapleton was selected for the 2020 Tokyo Olympics which took place in July 2021.

TECHNICAL OFFICIAL REPORT CONTINUED

- Rob Wiles managed to achieve an amazing 25 years as a Technical Official. Rob is the first Official in WA to complete 25 years of service. He is most famous for his decorative penalty boxes at GWM IRONMAN WA with a Christmas theme (pictured below).
- Other Service to Sport awards were given to:
 - Peter Hall for 5 years of service
 - Mark Ward for 10 years of service and
 - Gaye McKean for 15 years of service.

Two (2) major events were held in WA during the season – the GWM IRONMAN WA and the SunSmart Busselton 100. We fielded an entire Technical Team of WA Officials, which provided growth opportunity and experience for our team. The inaugural SunSmart Busselton 100 was held in April and once again provided opportunities for our Officials to be part of a mass participation event across two (2) days of racing. Both of these events require over 20 Officials, along with in-depth planning and assessment ahead of the event with Race Directors. Triathlon WA would like to thank these Officials for dedicating their time so that the athletes could race in a fair and safe environment.

Thank you to all of the volunteer Officials who get up in the dark and all kinds of weather to help at events. Your support and commitment to our sport is very much appreciated.

EVENTS REPORT

Triathlon WA sanctioned 122 events across the State during the 2021/22 season. At these events, there was 13,481 race finishes (total number of times athletes crossed the finish line during the season) which was a 6.96% increase on race finishes in 2020/21 and a 19.12% increase on race finishes in 2019/20. This increase in event participation, coupled with a slight decrease in TWA memberships, indicates athletes engaged in the sport as an independent activity but were hesitant to commit long-term. This trend could be attributed to the uncertainty surrounding the COVID-19 pandemic.

Of the total race finishes, Standard and Premium TWA Members raced 7,103 times and non-members raced 6,378 times. This demonstrates that there is a significant opportunity for the Association and its clubs to convert participating non-members.

Junior (5-15 year olds) race finishes totalled 1,621 during the 2021/22 season which was made up of 595 race finishes by members and 1,026 race finishes by non-members. This is a considerable increase (47.90%) on junior race finishes in 2020/21 which suggests more juniors have been exposed to the sport. There is an opportunity to reduce the member gap by increasing regular club training sessions for juniors across the State.

This season, there were nine (9) events in the Senior State Series and five (5) events in the Junior State Series. A senior athlete's seven (7) best races and a junior athlete's four (4) best races earned them Triathlete of the Year points. The number of race starts by members in State Series events increased by a notable 15.52% this year.

On Sunday, 6 February 2022, Triathlon WA hosted the Rockingham Foreshore Triathlon at Bell Park in Rockingham. Despite COVID-19 continuing to impact participation across the sporting industry, the Rockingham Foreshore Triathlon was once again a sold out event.

The event comprised of the following distances:

- Sprint Triathlon (750m swim, 20km cycle, 5km run)
- Enticer Triathlon (200m swim, 7km cycle, 2km run)
- SunSmart Kids Triathlon (100m swim, 3km cycle, 500m run)

There were a total of 618 registered participants, 20 volunteers and an estimated 700 spectators.

Conditions on race day were near perfect, with warm weather, very little wind and flat water. The morning was kicked off by the SunSmart Kids Triathlon Rockingham, which saw more than 50 junior athletes taking on the swim, bike, run course. The Enticer competitors took to the course next, followed by the Sprint athletes.

Being both a Junior and Senior State Series event competition was fierce across the board, but the Sprint race was especially exhilarating with some of WA's top talent taking on the fast, flat course in pursuit of the State Championship title.

Experienced triathlete Guy Crawford (Fremantle Tri Club) lead the pack for most of the race, but young-gun Zeke Tinley (Bunbury Tri Club) put the pedal to the metal on the run course to overtake Crawford and claim the State Sprint Champion title in a time of 00:56:28. Crawford came in second (2nd) a minute later and para-triathlete David Bryant (Stadium Tri Club) claimed third (3rd) place.

Female athlete Aleisha Wesley (North Coast Tri Club) was not far behind the male competitors, dominating the female field to finish in a time of 1:01:57. Wesley was crowned the Open Female champion taking her winning streak to an astonishing five (5) State Titles in a row for the 2021/22 season. Team XTR Tri Club athlete Indie Arbuckle finished second (2nd) and Kate Bevilaqua (Fremantle Tri Club) crossed the line in third (3rd) place.

SUNSMART BUSSELTON FESTIVAL OF TRIATHLON

The SunSmart Busselton Festival of Triathlon took place on Friday, 29 April to Sunday, 1 May 2022. More than 1800 competitors flocked to Barnard Park in Busselton to participate in the Festival's events with sunshine and pleasant racing conditions all weekend.

Following the decision to end the licensing agreement with IRONMAN, the 21st edition of the Festival featured a new look and several new events.

Friday afternoon kicked off at twilight with the Keep on Running Busselton Fun Run. This race had three (3) distance options including a 500m Dash, the Magic Mile and a 5km Fun Run. There was a significant prize pool up for grabs in the Open category with Sam Mileham pipping Kurt Wesley for the win in a nail-biting finish. The first Open female to cross the 5km finish line in a blistering time of 18 minutes and 33 seconds was Lauren Hyde-Cooling.

As the sun rose on Saturday, 30 April, 1200+ Individual, Team and AquaBike competitors were getting ready to race in the first ever SunSmart Busselton 100. This marquee event was also the Triathlon WA State Long Course Championship for 2021/22.

From the 2km swim leg, Kurt Wesley (North Coast Tri Club) was the first athlete out of the water followed closely by Guy Crawford (Fremantle Tri Club) and Nathan Saunders. James Martin (Bunbury Tri Club) had the fastest overall cycle time across the 80km ride, but it was on the 18km run course that athletes were really put to the test.

Australian Defence Force athlete Alex Stuart finished in an astonishing time of 03:28:05 to claim the WA State Long Course Champion title and SunSmart Busselton 100 overall male winner. Less than two (2) minutes later, Wesley finished in second (2nd) place, followed closely by Mark Radziejewski in third (3rd) place.

In the female field, Australian Capital Territory athlete Tracy Clinch was crowned SunSmart Busselton 100 overall female winner in an incredible time of 3:49:31. Felicity Sheedy-Ryan (UWA Tri Club) used her experience to take out second (2nd) place, two (2) minutes behind Clinch. 2020 Champion, Dimity Lee-Duke (Bunbury Tri Club) finished in third (3rd) position.

In the age-group field, Rockingham triathlete Brett Johnson crossed the line in just 03:34:53 to finish in sixth (6th) place overall. Fiona Whelan was the fastest female age-group athlete in a time of 04:04:25.

AquaBike athletes completed the swim and bike portion of the SunSmart Busselton 100, with a 350m run to the finish line. Brad Kaye (North Coast Tri Club) and Alison Thompson (Exceed Tri Club) were the fastest male and female across the line.

Sunday morning brought another fantastic day of racing with the first ever Busselton Foreshore Sprint (750m swim, 16km bike, 4km run) and Enticer (200m swim, 8km bike, 2km run) races. This event sold out three (3) months prior to race day. The waitlist was also full.

David Bryant (Stadium Tri Club) put on an exceptional performance to win the Foreshore Sprint in 52 minutes and 14 seconds. Junior athletes Joshua Neervoort (Fremantle Tri Club) and Joshua Fletcher (North Coast Tri Club) took out second (2nd) and third (3rd) place respectively. The fastest overall female was Rebecca Kierath (Exceed Tri Club) with Stephanie White and Kimberley Hallett rounding out the podium. Will Cramsie (North Coast Tri Club) and Indie Arbuckle (Team XTR Tri Club) were the fastest athletes in the Enticer distance.

After the start of the Foreshore events, we saw the SunSmart Kids Triathlon Busselton. Over 260 children aged 7-15 years participated across the two (2) distances (short and long). This event was participation-focused, so every child was a winner.

Athletes and visitors of all ages enjoyed festivities in the Event Village including the Chat with the Pros, Transition Tours, the Technical Official Hot Desk, face painting, rock climbing, a caricaturist, the VIP function, food trucks, coffee vans, a livestream of the action on the big screen, and the many stalls at the Health and Lifestyle Expo.

This year, a Draft Legal component was introduced to the Festival to give our aspiring Elite Junior athletes an opportunity to race in a mixed relay format. The young guns competed in blistering pace over the course (200m swim, 4km bike and 2km run) before tagging their teammates. Any mistake was crucial as the gaps opened up in this high intensity racing. The team of Daniel Stewart (EFS Tri Club) and Will Cramsie (North Coast Tri Club) came in first for the win, with Indie Arbuckle (Team XTR Tri Club) and Ava Henville (Exceed Tri Club) second and rounding out the podium in third was Jacob Palmer (Exceed Tri Club) and Rebecca Puccini (UWA Tri Club). The future looks bright for all these juniors pushing their limits on short, high intensity racing and it is great to have another opportunity for them in Busselton.



Opinion



1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Preparation

The financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 2015. The Board Members have determined that Triathlon Western Australia Inc. is not a reporting entity.

The financial report covers Triathlon Western Australia Inc. as an individual entity. Triathlon Western Australia Inc. is an association incorporated in Western Australia under the Associations Incorporation Act 2015.

The principal activity of Triathlon Western Australia Inc. is the governance, development and delivery of triathlon, duathlon, aquathlon and health in Western Australia.

The report has been prepared in accordance with the requirements of the Associations Incorporation Act 2015 and the following Australian Accounting Standards:

AASB 101	Presentation of Financial Statements
AASB 107	Statement of Cash Flows
AASB 108	Accounting Policies, Changes in Accounting Estimates and Errors
AASB 1048	Interpretation of Standards
AASB 1054	Australian Additional Disclosures

No other applicable Accounting Standards, Australian Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

The financial report has been prepared on an accrual basis and is based on historical costs. It does not take into account changing money values, or except where stated, current valuations of non-current assets. Cost is based on the fair values of the consideration given in exchange for assets.

The following is a summary of the material accounting policies adopted by Triathlon Western Australia Inc. in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, CONTINUED

Significant accounting judgments, estimates and assumptions

The carrying amount of certain assets and liabilities is often determined based on estimates and assumptions of future events. The key estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of certain assets and liabilities within the next annual reporting year are:

(i) Impairment of non-financial assets

The Association assesses impairment of all assets at each reporting date by evaluating conditions specific to the Association and to the particular asset that may lead to impairment. These include asset performance, technology and economic and political environments. If an impairment trigger exists, the recoverable amount of the asset is determined.

(ii) Estimation of useful lives of assets

The estimation of the useful lives of assets has been based on historical experience as well as manufacturers' warranties (for plant and equipment) and turnover policies. In addition, the condition of the assets is assessed at least once every year and considered against the remaining useful life. Adjustments to useful lives are made when considered necessary.

(iii) Long service leave

The Association measures long service leave liability based on estimates of future employee retention rates and pay increases.

Cash and cash equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with banks, other highly liquid investments with original maturities of three months or less, and bank overdrafts.

For the purposes of the statement of cash flows, cash includes cash and cash equivalents as defined above, net of outstanding bank overdrafts.

Trade and other receivables

A receivable represents the Association's right to an amount of consideration that is unconditional (i.e., only the passage of time is required before payment of the consideration is due). Refer to accounting policies of financial assets, Financial instruments – initial recognition and subsequent measurement.

Financial instruments

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity.

i) Financial assets

Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost, fair value through other comprehensive income (OCI), and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Association's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Association has applied the practical expedient, the Association initially measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs.

In order for a financial asset to be classified and measured at amortised cost or fair value through OCI, it needs to give rise to cash flows that are 'solely payments of principal and interest (SPPI)' on the principal amount outstanding. This assessment is referred to as the SPPI test and is performed at an instrument level.

The Association's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both.

Subsequent measurement

For purposes of subsequent measurement, financial assets are classified in four categories:

- Financial assets at amortised cost (debt instruments)
- Financial assets at fair value through OCI with recycling of cumulative gains and losses (debt instruments)
- Financial assets designated at fair value through OCI with no recycling of cumulative gains and losses upon derecognition (equity instruments)
- Financial assets at fair value through profit or loss.

Financial assets at amortised cost (debt instruments)

This category is the most relevant to the Association. The Association measures financial assets at amortised cost if both of the following conditions are met:

- The financial asset is held within a business model with the objective to hold financial assets in order to collect contractual cash flows; and
- The contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding

Financial assets at amortised cost are subsequently measured using the effective interest (EIR) method and are subject to impairment. Gains and losses are recognised in profit or loss when the asset is derecognised, modified or impaired.

The Association's financial assets at amortised cost includes cash and cash equivalents and trade and other receivables.

Financial instruments (continued)

Derecognition

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised when:

- The rights to receive cash flows from the asset have expired; or
- The Association has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a 'pass-through' arrangement; and either (a) the Association has transferred substantially all the risks and rewards of the asset, or (b) the Association has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Association has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risks and rewards of ownership. When it has neither transferred nor retained substantially all of the risks and rewards of the asset, nor transferred control of the asset, the Association continues to recognise the transferred asset to the extent of its continuing involvement. In that case, the Association also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Association has retained.

Impairment of financial assets

The Association recognises an allowance for expected credit losses (ECLs) for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Association expects to receive, discounted at an approximation of the original effective interest rate.

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12-months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

For trade receivables, the Association applies a simplified approach in calculating ECLs. Therefore, the Association does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Association has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

The Association considers a financial asset in default when contractual payments are 60 days past due. However, in certain cases, the Association may also consider a financial asset to be in default when internal or external information indicates that the Association is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Association. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Financial instruments (continued)

ii) Financial liabilities

Initial recognition and measurement

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, and payables.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Association's financial liabilities include trade and other payables.

Subsequent measurement

The measurement of financial liabilities depends on their classification, as described below:

Financial liabilities at fair value through profit or loss

Financial liabilities at fair value through profit or loss include financial liabilities held for trading and financial liabilities designated upon initial recognition as at fair value through profit or loss.

Financial liabilities are classified as held for trading if they are incurred for the purpose of repurchasing in the near term.

Gains or losses on liabilities held for trading are recognised in the statement of profit or loss.

Financial liabilities designated upon initial recognition at fair value through profit or loss are designated at the initial date of recognition, and only if the criteria in AASB 9: Financial instruments are satisfied. The Association has not designated any financial liability as at fair value through profit or loss.

Derecognition

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the statement of profit or loss.

Plant and equipment

Plant and equipment is stated at historical cost less accumulated depreciation and any accumulated impairment losses. Such cost includes the cost of replacing parts that are eligible for capitalisation when the cost of replacing the parts is incurred. All other repairs and maintenance are recognised in the profit or loss as incurred.

The cost of each item of plant and equipment is written off over its expected economic life, adjusted for any salvage value if applicable. Depreciation is provided for at the rates specified in the small business entity simplified depreciation tax rules.

Derecognition

An item of plant and equipment is derecognised upon disposal or when no further future economic benefits are expected from its use or disposal.

Impairment

Plant and equipment is reviewed for impairment if there is any indication that the carrying amount may not be recoverable.

Intangible assets

Intangible assets acquired separately are measured on initial recognition at cost. Following initial recognition, intangible assets are carried at cost less any accumulated amortisation and accumulated impairment losses. Internally generated intangibles are not capitalised and the related expenditure is reflected in profit or loss in the period in which it is incurred.

The useful lives of intangible assets are assessed as either finite or indefinite. Intangible assets with finite lives are amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at the end of each reporting period. Changes in the expected useful life or the expected pattern of consumption of future economic benefits embodied in the asset are considered to modify the amortisation period or method, as appropriate, and are treated as changes in accounting estimates. The amortisation expense on intangible assets with finite lives is recognised in the statement of profit or loss and other comprehensive income in the expense category that is consistent with the function of the intangible assets.

Intangible assets with indefinite useful lives are not amortised, but are tested for impairment annually. The assessment of indefinite life is reviewed annually to determine whether the indefinite life continues to be supportable. If not, the change in useful life from indefinite to finite is made on a prospective basis.

Websites

Websites are initially recognised at cost and are amortised on a straight-line basis over 5 years.

Trade and other payables

Trade payables and other payables are carried at amortised cost and due to their short-term nature are not discounted. They represent liabilities for goods and services provided to the Association prior to the end of the financial year that are unpaid and arise when the Association becomes obliged to make future payments in respect of the purchase of these goods and services. The amounts are unsecured and are usually paid within 30 days of recognition.

Provisions

Provisions are recognised when Triathlon Western Australia Inc. has legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result, and that outflow can be reliably measured.

Provision recognised represent the best estimate of the amounts required to settle the obligation at reporting date.

GST

Revenues, expenses and assets are recognised net of the amount of GST except:

- when the GST incurred on a purchase of goods and services is not recoverable from the taxation authority, in which case the GST is recognised as part of the cost of acquisition of the asset or as part of the expense item as applicable, and
- receivables and payables, which are stated with the amount of GST included.

The net amount of GST recoverable from, or payable to, the taxation authority is included as part of receivables or payables in the statement of financial position.

Commitments are disclosed net of the amount of GST recoverable from, or payable to, the taxation authority.

Employee entitlements

(i) Wages, salaries and annual leave

Liabilities for wages and salaries, including non-monetary benefits and annual leave expected to be settled within 12 months of the reporting date are recognised in respect of employees' services up to the reporting date. They are measured at the amounts expected to be paid when the liabilities are settled and reported as current liabilities in the statement of financial position.

(ii) Long service leave and other employee entitlements expected to be settled more than 12 months from the reporting date

The liability for long service leave and other employee entitlements expected to be settled more than 12 months from the reporting date is recognised and measured as the present value of expected future payments to be made in respect of services provided by employees up to the reporting date using the projected unit credit method. Consideration is given to expected future wage and salary levels, experience of employee departures, and years of service. Expected future payments are discounted using market yields at the reporting date on national government bonds with terms to maturity and currencies that match, as closely as possible the estimated future cash outflows.

Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Revenue recognition relating to the provision of services is determined with reference to the stage of completion of the transaction at reporting date and where outcome of the contract can be estimated reliably. Stage of completion is determined with reference to the services performed to date as a percentage of total anticipated services to be performed. Where the outcome cannot be estimated reliably, revenue is recognised only to the extent that related expenditure is recoverable.

All revenue is stated net of the amount of goods and services tax (GST).

Grants and Subsidies

Grant income for contracts with sufficiently specific performance obligations is recognised over time as the performance obligations are satisfied. Grant income for contracts that do not have sufficiently specific performance obligations is recognised immediately upon receipt.

Income Tax

The financial statements have been prepared on the basis that Triathlon Western Australia Inc. is exempt from income tax.

Comparative information

Comparative information has been restated wherever possible to conform to current year figures.
