## DELEGATES AND VOTING

Pursuant to Rule 10, each Voting Member is entitled to appoint an individual as its representative to attend and vote on behalf of that Voting Member at the general meeting.

A Voting Member may appoint more than 1 representative but only 1 representative may exercise the Voting Member's powers at any General Meeting.

Voting Members must notify the State Services Manager their appointed authorised representative no later than 48 hours prior to the General Meeting.

Proxy voting is not permitted at General Meetings.
