NSW Triathlon continues to grow from strength to strength with more members, more sanctioned multisport events and more startlines than any other State.

- 383 sanctioned multisport events in New South Wales
- 67,114 start lines (compared to 54,493 in 2024, attributed to the growth in running events held in conjunction with triathlon festivals)
- Our club network delivered 327 sanctioned events (compared to 184 club events in the rest of Australia combined)
- Prudent financial management delivers an operating surplus of \$21,559
- Reserves increased to over \$594,000
- A network of 61 affiliated clubs run by volunteers are at the heart of our success.

The future of NSW Triathlon remains bright

It is a pleasure to present my first Annual Report as President of NSW Triathlon. Since stepping into the role on 1 July 2024, it has been a year of building on our strong foundations and continuing to grow our footprint across the state.

We have undertaken a more strategic and consultative approach this year, engaging more deeply with our clubs to ensure their needs, insights, and aspirations directly inform our planning and priorities. Strengthening these connections has been essential to aligning our direction with the realities and opportunities within our community.

Increased financial support from the Office of Sport has allowed us to continue supporting our clubs through 'Finish Lines, Not Finish Times' a proven initiative that connects clubs with their communities and encourages greater participation. We have also been hard at work developing a new participation project targeted at increasing opportunities within our secondary school network.

The Billigence Pathway Series provides the ideal platform to inspire the next generation of NSW triathletes as we look toward Los Angeles 2028 and the Brisbane 2032 Olympics. The success of the program was highlighted by Jack Caldwell's dominance in the junior space, culminating in his crowning as Oceania Junior Champion in Devonport.

Our financial competence and careful management of funding ensures NSW Triathlon remains strong, while our sponsorship partnerships were nurtured and aligned with our strategic direction. I want to acknowledge Billigence, Reflections Holiday Parks and Scody Australia for their ongoing support and valued affiliations.

Our staff, guided by CEO Adam Wicks, have worked with collective purpose and positive collaboration to deliver a diverse range of projects over the past 12 months. Their work connecting with clubs, members, and commercial event partners has been integral to achieving our goals and advancing our strategic initiatives.

We remain committed to the growth and development of our sport, working with AusTriathlon towards a whole-of-sport strategic direction. The NSW Triathlon Board continues to believe our members are best served by remaining independent of the whole-of-sport management model, affording us greater flexibility and a stronger voice to deliver more targetted grass roots programs to our clubs and member community.

At the heart of our success is the governance and strategic direction provided by our dedicated volunteer Board of Directors. I would particularly like to acknowledge former President Glenn Schwarzel, whose mentorship has been invaluable in my first year. Glenn remains actively involved in shaping the direction of our sport, and his ongoing commitment continues to strengthen NSW Triathlon.

Thank you also to Nicky Western, Megan Goodwin, Sarah Maguire, Ja Davis (Elected Directors), and Lucy Burgmann and Todd Alexis (Appointed Directors), for their continued leadership and dedication to the organisation.


Financial performance summary



Clubs

The 2024/2025 season showed us that the sport is more vibrant than ever with commercial and club races taking place almost every week from September till June. In a sport that see many people come and go to tick that item off their bucket list, our clubs are the cornerstone of countless participation opportunities, enabling athletes to achieve their goals while fostering a supportive community, where individuals can better themselves both physically and mentally off the field.

Similar to the previous seasons, we put an emphasis on getting clubs from all corners of the state to participate in the Interclub Leagues as we firmly believed that having a race calendar is the greatest way to boost club engagement. Whilst certain clubs are always very eager to participate and try to win their respective leagues from the get-go, some warmup to the idea of winning as the season goes after scoring high points during one of their favourite events.

On the topic of the Interclub, a new point scoring system was implemented to better reward the athletes finishing in the Top5 of their age group. The winner of their age group could earn 10 points, with 9 on offer for second place, and 9 for the person rounding up the podium. All the way to 1 point for the athlete finishing 10th in the age group. The participation points system was also increased to 15,30 and 45 points based on the % of club's members racing at the event. The max out rule was amended to consider the changes made with the performance point with the maximum tally set at 200 points.





The seventh edition of the Interclub, affectionately known as Interclub 07 or ICL07 started with Ironman Western Sydney at the Penrith Regatta centre and finished with Club Champs in Forster.

In between we saw races across the state ranging from the club distance in the Central West to commercial races by NX Sports, Ironman Group, Activate Events, Challenge or H Events.

The new point scoring system made some of the leagues tally tighter than ever.

For the first time since its inception, the South Coast series didn't take place but has now returned this current season and will be interesting since the Illawarra Cannons are determined to dethrone the Jervis Bay Dolphins.

With Forster Main Beach and the brand-new Surf Life Saving Club as the backdrop for the weekend, the weather was nothing short of spectacular, setting the stage for a fantastic event.

Over 650 athletes, 150 volunteers, and a dedicated team of 15 Technical Officials came together. Club kits and bespoke Club Championship gear were worn with pride as athletes worked together, in ideal racing conditions, to help put their team in the running for title of Club Champions. The race culminated with two loops of a scenic 4km run, weaving through the now-iconic 'Club Tent Alley' which was lined with clubmates cheering, clapping, and chanting.

It was a weekend of memorable breakthroughs, including long-awaited triumphs. Balance Triathlon Club finally claimed victory in Division 2, ending an 18-year wait after countless runner-up finishes. Their win over rivals Central Coast Triathlon Club was hard-earned and deeply deserved.

Over in Division 1, Cronulla Triathlon Club made waves by ending Warringah Triathlon Club's incredible five-year winning streak. Warringah may have finished second this year, but their legacy is undeniable — a true dynasty that raised the standard for all! Cronulla's success didn't stop there. Their juniors also claimed back-to-back titles, underlining the strength of their club from the grassroots up. 


2024/25 NSW Triathlon Coach Education and Pathway

The 2024/25 season commenced with a NSW Triathlon Pathways Camp at Point Wolstoncroft, located at the top of the Central Coast. The long weekend focused on skill development—particularly cycling skills—preparing athletes for the Billigence Pathway Series and other draft-legal opportunities...

Four (4) rounds of the Billigence Pathway Series were held, with excellent attendance across all rounds from athletes of varying abilities. This environment is ideal for competitive growth and development for emerging athletes across NSW and ACT.

The ongoing support from Billigence as our naming rights sponsor, combined with the enthusiasm and collaboration of our clubs, volunteers, athletes, parents, and coaches, has made the series an invaluable experience for our pathway community. Over the years, we have witnessed entry-level competitors racing alongside Olympians, young female athletes challenging the boys, and proud parents and coaches watching the future of our sport unfold before their eyes. We are thrilled that Jana and Michael Kapr have committed to extending their support for the Billigence Pathway Series into the 2025/26 season. Club interest continues to grow, reflecting their shared dedication to nurturing the next generation of Olympic hopefuls. Each season, the series evolves through collaboration and innovation, resulting in fast, exciting racing and a strong sense of community.



We continued to deliver skills clinics for ROSTA and TACTTA athletes, complemented by Pathway Camps throughout the year. Following the season kick-off camp at Point Wolstoncroft, the Development Squad Camp at Wollongong Surf Leisure Resort prepared athletes for the first Billigence race of the season. Preseason testing and skill development formed the foundation of these camps, including running video assessments, functional movement screenings, bunch riding, and open-water skill sessions. NSW Triathlon also successfully delivered Masterclasses across the state, focusing on open-water and bunch-riding proficiency.

The Regional Academies of Sport (RAS) continued to play an essential role in developing junior triathletes through quality holistic programs. In 2024/25, the academies included Central Coast, Hunter, Illawarra, Northern Inland, South West Sydney, Western Region, Western Sydney, and the newly added North Coast Academy of Sport.

The ROSTA and TACTTA programs continue to provide quality training opportunities for NSW and ACT athletes not serviced by a Regional Academy program, ensuring inclusive development pathways across the state.

Runaway Bay Super Sprint Race Weekend was held in January 2025 due to track refurbishments. NSW and ACT athletes performed strongly across three days of competition, with Jack Caldwell winning the Junior Male Division and Jake Barritt finishing second in the Youth Male category.

After a reschedule and reshuffle to the calendar, a National Sprint race was set in Elwood, Victoria. Jack Caldwell dominated the race in the junior category, again taking out the win with Wade Barr coming a close second place. At the 2025 Oceania Sprint Championship in Devonport in March, Jack Caldwell continued with great form to take the Junior Male win, with fellow NSW Athlete Claire Spicknall taking an impressive second place in the Junior Female category, both securing a place to race for Australia in the Junior World Team in Wollongong.

Coach Education

Throughout 2024/25, NSW Triathlon delivered two Foundation Coaching Courses and one Development Coaching Course. The third and final year of the Inspire to Tri Female Leadership Program was delivered – a program designed to inspire and upskill the next generation of female coaches.

The program significantly empowered participants, enhancing confidence and providing mentorship from experienced professionals. As a result, female representation among Development Coaches increased from 23% to 51%, and Foundation Coaches maintained a 50% gender balance.

This program serves as an accelerator for gender equity – achieving measurable change that the United Nations estimates would take 140 years to achieve globally. We thank the NSW Office of Sport for the Her Sport Her Way grant support, and all guest speakers, mentors, and facilitators who contributed to the program's success.

- Club race directors, committees, and volunteers for delivering high quality events that fuel athlete development.
- Parents for embracing our pathway philosophy and supporting athlete growth with empathy and enthusiasm.

The NSW Triathlon Technical Committee is a subcommittee of the Board, chaired by the Manager Technical. Other committee members are appointed by the Board for a two-year term. The 2024/25 Technical Committee met monthly by teleconference, with attendances as follows::

At the end of the season Grant Holman and Catherine Ross were required to step down from the Committee, having completed their two-year term. This did not preclude them from nominating for the 2025/26 committee.

Skills of the 2024/25 Technical Committee

The Committee consisted of a diverse range of technical experience (between 8 and 19 years of service). Individuals within the Committee brought with them the following skills and experience to the Committee:

On behalf of the Board, the Technical Committee oversaw the development and training of over 57 accredited NSW Technical Officials in 2024/25. The main aims of the Committee were as follows:

- ensure a technical presence at every open, sanctioned event in NSW
- 2. provide high quality officiating at events
- provide a safe environment which gives opportunities for all officials to maximise their potential
- manage a program which exceeds the minimum requirements of Sport Australia's officiating accreditation scheme
- 5. contribute to NSW Triathlon meeting its responsibilities under NSW legislation.




Event Sanctioning in 2024/25






In 2024/25, 64% of all sanctioned club events held nationally were conducted by NSW clubs.

NSW TRIATHLON

2024/25 Achievements

Delivery of Ongoing Education and Personal Development

At the State level:

- eleven candidates completed Module 10 of the Local Technical Official (LTO) course with Nine successfully gaining full LTO accreditation status this season, once practical Field-of-Play (FOP) assessments were completed. 3 graduated as part of the new LMS Online course.
- seven candidates were invited to do the new LMS online Regional Technical Official (RTO) and will complete their FOP practical assessments in the 2025-2026 season.
- eight LTOs were given STT roles with an experienced TO acting as a 'phone a friend'.
- in association with the NSW Office of Sport, eight technical officials attended High Performance Officiating workshops on-line that were designed to improve their performance on the field of play.
- Craig Cusack was named NSW "TO of the Year" at Club Champs.
- all NSW Officials completing the LMS Technical Re-Accreditation in preparation for season 2025-2026.
- 12 newsletters were delivered covering safety reminders, technical resources and experiences from our TOs on the Field of Play.
- the Annual Technical Forum was held in January 2025 with guest speaker, Michael Thompson, who spoke of his experience as a TO at the Paris Paralympics as well as an owner of SuperTri.
- we celebrated our Years of service awards. Five TOs for 5 years,
 Two for 10 years and One for 15 years. Thank you all.

At the National level:

- the AusTriathlon 2024 Annual Technical Official Awards went to Christina Thorne as a co-winner of the Rob George Award and David Williams as a co-winner of the John Ison Award.
- nine NSW officials were allocated 13 Senior Technical Team (STT) roles at six different Events of National Significance (EONS) by AusTriathlon.
 12 Officials also travelled interstate to attend EONS events.

At the International level:

- we have 8 World Triathlon (WT) accredited TOs in NSW 5
 Continental Technical Officials (CTO, level 2) and 3 National Technical
 Officials (NTO, Level 1). We also had 11 TOs nominate to attend a World
 Triathlon Level 1 course that will be held in August 2025
- one CTO Official was appointed to STT roles at a World Triathlon Mooloolaba Oceania event and Townsville Multisport World Championships with 6 more NSW officials also attending the Townsville event in August 2024.
- another of our CTO Officials was appointed to an STT role at Devonport World Triathlon World Para Series and Oceania races with 5 NSW Officials also attending this event.
- four NSW Officials were selected to be part of the Australian Officials Team who attended the Ironman 70.3 World championships in Taupo, NZ, in December 2024
- one CTO Official was selected by WT as a TD for the World Triathlon Championship Finals in Wollongong, October 2025

2. Attendance at Events

Accredited NSW Triathlon officials attended 98% of all open sanctioned events that required technical officials. The one event that we were unable to service was held in Warren. In this case the Sanctioning Officer worked remotely with the Event Organiser to ensure a safe event.

Relationship with AusTriathlon

From time to time, and with the approval of the Executive Director, both the TNSW Manager Events and Manager Technical aided AusTriathlon's Technical and Sanctioning Manager in the management of the National Officiating program. This included:

- · sanctioning of all ACT and Northern Territory events.
- working on a committee to deliver the 2025 Race Competition Rules.
- assistance with the ongoing development of the Online Sanctioning Portal and Learning Management System.
- development and delivery of training programs to technical officials.
- Running Australia wide LTO Module 10 calls.
- · secretary to all STTA meetings.
- · maintaining a register of EONS STT roles.

Conclusion

The NSW technical program remains in a strong position. The management of the technical program meets the officiating requirements of Sport Australia. Opportunities continue to be provided to officials to maximise their potential via mentoring, targeted training, and challenging field of play appointments.

A big thank you to all event organisers, officials, and participants for continuing to keep our sport safe, fun, and fair in this season.

Notes to the Financial Statements

Triathlon New South Wales Limited For the year ended 30 June 2025

1. Statement of Significant Accounting Policies

The financial statements are general purpose financial statements that have been prepared in accordance with Accounting Standards (including Australian Accounting Interpretations) and the Corporations Act 2001.

The format and content of the financial report apply the Simplified Disclosure Requirements as provided for by the Australian Accounting Standards Board in Standards AASB 1060 /AASB 1053, being Tier 2 Company.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in financial statements containing relevant and reliable information about transactions, events, and conditions. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless otherwise stated.

The financial statements cover the economic entity of Triathlon New South Wales Limited as an individual economic entity. The Company is not-for-entity, limited by guarantee, incorporated, and domiciled in Australia.

The financial statements of Triathlon New South Wales Limited for the year ended 30 June 2025 were authorised for issue in accordance with the resolution of the directors on XXX September 2025.

The following is a summary of the material accounting policies adopted by the Company in the preparation of the financial report. The accounting policies have been consistently applied unless otherwise stated.

a. Basis of Preparation

REPORTING BASIS AND CONVENTIONS

The financial statements have been prepared on an accrual basis and are based on historical costs, modified, where applicable, by the measurement of the fair value of selected non-current assets, financial assets, and financial liabilities.

The financial report is presented in Australian Dollars which is the Company's functional and presentation currency.

b. Comparative Figures

Comparative figures have been adjusted and reclassified where necessary to conform to changes in presentation for the current financial year.

c. Inventories

Inventories are measured at the lower of cost or net realisable value. Inventories acquired at no cost, or for nominal consideration, are valued at the current replacement cost at the date of acquisition.

d. Property, Plant, and Equipment

Each class of property, plant, and equipment is carried at cost or fair values as indicated, less, where applicable, accumulated depreciation and impairment losses.

PLANT AND EQUIPMENT

Plant and equipment are measured on a cost basis less depreciation and impairment losses.

The carrying amount of plant and equipment is reviewed annually by directors to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the asset's employment and subsequent disposal. The expected net cash flows have been discounted to their present values in determining recoverable amounts.

DEPRECIATION

The depreciable amount of all fixed assets, excluding freehold land, is depreciated on a straightline basis over the asset's useful life to the Company commencing from the time the asset is held ready for use.

The depreciation rates used for each class of depreciable assets are:

Plant and equipment

10 - 50%

The assets residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

Asset class carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are included in the statement of profit or loss income. When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained earnings.

e. Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of less than three months, and bank overdrafts. Bank overdrafts are shown within short-term borrowings in current liabilities on the statement of financial position. Term deposits with an original maturity of three months or more have been shown as investments.

f. Employee Benefits

Provision is made for the Company's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled, plus related on-costs. Employee benefits payable later than one year have been measured at the present value of the estimated future cash outflows to be made for those benefits. In determining the liability, consideration is given to employee wage increases and the probability that the employee may not satisfy vesting requirements. Those cash outflows are discounted using market yields on national government bonds with terms to maturity that match the expected timing of cash flows.

Contributions are made by the entity to an employee superannuation fund and are charged as expenses when incurred

g. Financial Instruments

INITIAL RECOGNITION AND MEASUREMENT

Financial assets and financial liabilities are recognised when the entity becomes a party to the contractual provisions of the instrument. For financial assets, this is equivalent to the date that the entity commits itself to either purchase or sell the asset (i.e. trade date accounting is adopted).

Financial instruments are initially measured at fair value plus transaction costs except where the instrument is classified 'at fair value through profit or loss' in which case transaction costs are expensed to profit or loss immediately. Financial instruments are classified and measured as set out below.

DERECOGNITION

Financial assets are derecognised where the contractual rights to receipt of cash flows expire, or the asset is transferred to another party whereby the entity no longer has any significant continuing involvement in the risks and benefits associated with the asset. Financial liabilities are derecognised where the related obligations are either discharged, canceled, or expired. The difference between the carrying value of the financial liability, which is extinguished or transferred to another party and the fair value of the consideration paid, including the transfer of non-cash assets or liabilities assumed, is recognised in profit or loss.

CLASSIFICATION AND SUBSEQUENT MEASUREMENT

Finance instruments are subsequently measured at fair value, amortized cost using the effective interest rate method, or cost. Fair value represents the amount for which an asset could be exchanged or a liability settled, between knowledgeable, willing parties. Where available, quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

FINANCIAL ASSETS AT FAIR VALUE THROUGH PROFIT OR LOSS

Financial assets are classified at 'fair value through profit or loss' when they are held for trading for the purpose of short-term profit-taking, where they are derivatives not held for hedging purposes, or when they are designated as such to avoid an accounting mismatch or to enable performance evaluation where a group of financial assets is managed by key management personnel on a fair value basis in accordance with a documented risk management or investment strategy. Such assets are subsequently measured at fair value with changes in carrying value being included in profit or loss.

i. Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are subsequently measured at amortised cost. Loans and receivables are included in current assets, except for those which are not expected to mature within 12 months after the end of the reporting period, which are classified as non-current assets.

ii. Held-to-maturity investments

Held-to-maturity investments are non-derivative financial assets that have fixed maturities and fixed or determinable payments, and it is the entity's intention to hold these investments to maturity. They are subsequently measured at amortised cost. Held-to-maturity investments are included in non-current assets, except for those which are expected to mature within 12 months after the end of the reporting period. If during the period the company sold or reclassified more than an insignificant amount of the held-to-maturity investments before maturity, the entire held-to-maturity investment would be tainted and reclassified available-for-sale.

iii. Available-for-sale financial assets

Available-for-sale financial assets are non-derivative financial assets that are either not capable of being classified into other categories of financial assets due to their nature or are designated as such by management. They comprise investments in the equity of other entities where there is neither a fixed maturity nor fixed or determinable payments. Available-for-sale financial assets are included in non-current assets, except for those which are expected to be disposed of within 12 months after the end of the reporting period.

iv. Financial liabilities

Non-derivative financial liabilities (excluding financial guarantees) are subsequently measured at amortised cost

FAIR VALUE

Fair value is determined based on current bid prices for all quoted investments. Valuation techniques are applied to determine the fair value for all unlisted securities, including recent arm's length transactions, reference to similar instruments, and option pricing models.

IMPAIRMENT

At the end of each reporting period, the Company assesses whether there is objective evidence that a financial instrument has been impaired. In the case of available-for-sale financial instruments, a prolonged decline in the value of the instrument is considered to determine whether impairment has arisen. Impairment losses are recognised in the statement of profit or loss income.

Provisions

Provisions are recognised when the Company has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result, and that outflow can be reliably measured. Provisions recognised to represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.

Contributions

Triathlon New South Wales Limited receives non-reciprocal contributions from the government and other parties for no or nominal value. These contributions are recognised at fair value on the date of acquisition upon which time an asset is taken up in the balance sheet and revenue in the income statement.

Revenue

Revenue from the sale of goods is recognised upon the delivery of goods to customers.

Grant revenue is recognised in the statement of profit or loss income when the entity obtains control of the grant, and it is probable that the economic benefits gained from the grant will flow to the entity and the amount of the grant can be measured reliably.

If conditions are attached to the grant which must be satisfied before it is eligible to receive the contribution, the recognition of the grant as revenue will be deferred as liabilities until those conditions are satisfied.

When grant revenue is received whereby the entity incurs an obligation to deliver economic value directly back to the contributor, this is considered a reciprocal transaction, and the grant revenue is recognised in the statement of financial position as a liability until the service has been delivered to the contributor, otherwise, the grant is recognised as income on receipt. Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument.

Revenue from the rendering of services is recognised upon the delivery of the service to the customers.

k. Intangibles

SOFTWARE

Software is recorded at cost. The software has a finite life and is carried at cost less any accumulated amortisation and impairment losses. It has an estimated useful life of between three to five years. It is assessed annually for impairment.

I. Goods and Services Tax (GST)

Revenues, expenses, and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

Cash flows are presented in the cash flow statement on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

m. Rounding of Amounts

The Company has applied the relief available to it under ASIC Class Order 98/100 and accordingly, amounts in the financial report and directors' report have been rounded off to the nearest \$1.

n. Impairment of Assets

At each reporting date, the Company reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expended to the statement of profit or

Where the future economic benefits of the asset are not primarily dependent upon the asset's ability to generate net cash inflows and when the entity would, if deprived of the asset, replace its remaining future economic benefits, value in use is determined as the depreciated replacement cost of an asset.

Where it is not possible to estimate the recoverable amount of an asset's class, the entity estimates the recoverable amount of the cash-generating unit to which the class of assets belongs.

Where an impairment loss on a revalued asset is identified, this is debited against the revaluation reserve in respect of the same class of asset to the extent that the impairment loss does not exceed the amount in the revaluation surplus for that same class of asset

o. Classification of leases in financial statements

Expenses relating to leases of low-value assets or short-term leases have been charged as an expense on a straight-line basis

p. Critical accounting estimates and judgments

The directors evaluate estimates and judgments incorporated into the financial statements based on historical knowledge and the best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the Company.

KEY ESTIMATES - IMPAIRMENT

The Company assesses impairment at each reporting date by evaluating conditions and events specific to the Company that may be indicative of impairment triggers. Recoverable amounts of relevant assets are reassessed using value-in-use calculations which incorporate various key assumptions.

q. Income tax

No provision for income tax has been raised as the entity is exempt from income tax under Division 50 of the Income Tax Assessment

12. Financial Instruments

Financial Risk Management

Treasury Risk Management

Financial Risk Exposures and Management

Foreign Currency Risk

Price Risk

The company is not exposed to any material commodity price risk.

Net Fair Values

The net fair values of listed investments, if relevant, are valued at the quoted market bid price at the balance date adjusted for transaction costs expected to be incurred. No financial assets or financial liabilities are readily traded on organised markets in standardised form other than listed investments. 
