LOCAL TECHNICAL OFFICIAL MODULE 10

COURSE DATES 2026

Purpose

The purpose of this document is to provide an overview of the Local Technical Official (LTO) Module 10 learning requirements and administrative processes associated with the LTO accreditation.

This document is designed to support learners, facilitators, assessors and state/territory technical teams ensuring consistent national implementation.

Module 10: Facilitated Behaviour & Scenario Discussion

Module 10 focuses on real-world application, scenario-based learning, and officiating behaviours. It gives learners the opportunity to discuss decision-making, clarify rules, and explore case-based examples with a qualified facilitator.

Delivery Format

- Delivered live online or in person
- Held approximately every six weeks
- Rotates between Tuesday, Wednesday, and Thursday evenings
- Runs for approximately 60–75 minutes
- Conducted using AusTriathlon's approved virtual meeting platform (Microsoft Teams)

Participants complete Module 10 after successfully completing Modules 1–9.

All Module 10 sessions commence at:

- **7:30pm AEDT** during Daylight Saving
- **7:30pm AEST** outside Daylight Saving

National time-zone equivalents are listed in the schedule.

- Lapsed officials

Post-Module 10 Follow-Up

Once learners have attended the Module 10 session, the following steps support their final progression toward accreditation.

1. Final Requirements Email

Participants will receive an email that includes:

- Confirmation of Module 10 completion
- A summary of any outstanding requirements
- Instructions for next steps
- Links to relevant modules, resources, and support contacts

This communication ensures learners understand their remaining obligations.

2. Launching the Field of Play (FOP) Assessment Module

Learners must:

1. Log into the AusTriathlon Learning Centre (ASLC)
2. Launch the Field of Play Assessment Module
3. Select their assigned State/Territory Assessor

Completing this step notifies AusTriathlon that the learner has met all prerequisites.

3. Assessor Selection

Learners must select the assessor aligned with their jurisdiction:

- New South Wales: *Sue Horsburgh*
- Western Australia: *Cathy Hoare*
- Queensland: *Catherine Ross*
- All other states and territories: *Kirrily Guinan*

4. Prerequisite Confirmation

After the assessor is selected, AusTriathlon will verify completion of:

- Modules 1–10
- SIA integrity modules
- ASC General Principles
- AusTriathlon membership
- WWCC requirements

Once verified, the Field of Play assessment can be scheduled, and accreditation finalised.
