2026 World Triathlon Para Series and 2026 Para Triathlon World Championships Selection Policy

(Updated June 2026, with updated PTS4 Male PTWCh Quota)

Part 1: Introduction

1.1. Scope

1.1.1. This Selection Policy (**Policy**) details the process and criteria by which the AusTriathlon (**AusTri**) Elite Selection Committee (**ESC**) selects Athletes (including guides¹) for nomination to World Triathlon (**WT**) for:

- a) the 2026 World Triathlon Para Series (**WTPS**) events;
- b) the 2026 Para Triathlon World Championships (**PTWCh**); and;
- c) the 2026 World Triathlon Para Team Relay (**PTR**) events

1.1.2. Individual WTPS events, the PTWCh, and the PTR are separate events with different selection criteria.

1.2. Individual event objectives

1.2.1. The primary objective of the Policy is to nominate Athletes who have demonstrated that they are likely to finish in the top 3 positions of a WTPS individual race event, or, in the case of PTWCh, the top 50% of the maximum allocation slots of the athlete's respective class, according to WT qualification criteria.

1.2.2. The secondary objective of the Policy is to nominate Athletes for development purposes, with the aim of developing athletes for medal success at the 2028 and 2032 Paralympic Games.

1.3. Para Team Relay objectives

1.3.1. The primary objective of the selection policy for the PTR is to provide race opportunities to develop a team of Athletes for medal success at future Benchmark Events.

Part 2: Definitions

Key terms used in this Selection Policy are set out in the list below:

Athlete means a person who participates in the Sport

AusTri means AusTriathlon.

Automatic Nomination means the process of selecting Athletes for nomination to WT for WTPS races by reason of performance.

Discretionary Nomination means the process of selecting Athletes for nomination to WT for WTPS races at the discretion of the ESC.

Eligible Athlete means an Athlete that meets the requirements in clause 3.

ESC is the AusTri Elite Selection Committee. This committee has been appointed by the AusTri Board, to administer and implement this Policy. The names of each of the Selectors is published on the AusTri website.

HPD describes the role of the AusTri High Performance Director, or, their nominated delegate.

PTR means Para Team Relay.

PTWCh means the Para Triathlon World Championships.

Relay Distance triathlon consisting of 4 Athletes each undertaking a 125 – 150m swim, 3.5 – 4km bike and 0.8 – 1km run.

Selection describes the process by which the ESC may consider the performance of an Athlete, apply its expert opinion, and determine whether the Athlete meets the objective of this Policy.

Sport means ParaTriathlon.

Standard Distance para-triathlon consisting of 750m swim, 20k cycle, 5km run.

WTPC means the World Triathlon Para Cup Events.

WT means World Triathlon.

WTPS means the World Triathlon Para Series Events, including the PTWCh event.

WT Para Ranking is used to determine Athlete's eligibility to enter World Triathlon events.

Part 3: Mandatory Eligibility Requirements

3.1. To be considered for nomination to WT for a WTPS, PTWCh or PTR event, Athletes must satisfy the following eligibility requirements:

- a) hold a current AusTri Professional Licence;
- b) is an Australian citizen or holds an Australian permanent residency visa, and, where the Athlete holds an Australian permanent residency visa, he/she has been lived in Australia for a minimum of 1 year;
- c) not be serving an Anti-Doping Rule Violation (ADRV) sanction or have an ADRV matter pending an outcome at the time of nomination;
- d) not be serving any sanctions imposed by Sports Integrity Australia for Prohibited Conduct;
- e) have signed the AusTri Athlete Agreement, or, be willing to sign an AusTri Athlete Agreement within 7 days of selection;
- f) satisfies all WT Competition Rules;
- g) be in good financial standing with AusTriathlon;
- h) as a categorised athlete, have submitted to the HPD their 2026 Athlete Plan by 28 February 2026; or as a non-categorised athlete, have submitted their 2026 Athlete Plan within 7 days of the nomination date to the HPD; and
- i) have signed an athlete acknowledgement attesting to having read and understood the Aus Triathlon Selection Policies.

3.2. Eligibility as it relates to Classification:

- 3.2.1 Only qualified Athletes that meet the WT classification rules, have been allocated an international sport class and an appropriate sport class status by a WT classification panel, as outlined, will be eligible to be nominated to the Team.
- 3.2.2 For World Triathlon World Championships: Athletes must have a “Review” (R), “Fixed Review Date” (FRD) or “Confirmed” (C) classification status on the World Triathlon Classification Master List at the time of the production of the start lists.
- 3.2.3 For all other World Triathlon Para triathlon events, Athletes must have a “Provisional Classification Status” (PCS), “Review” (R) or “Confirmed” (C) classification status at the time of the production of the start list or if entered as “New” (N) or “Provisional Competition Status” (PCR), must undergo classification if available at the event.”
- 3.2.4 Athletes agree to abide by the WT classification rules and regulations, the IPC Athlete Classification Code and any relevant AusTri and Paralympics Australia classification policies and requirements, including attending classification assessment as required.
- 3.2.5 Athletes agree to complete any classification education modules as released by WT, AusTri or Paralympics Australia.
- 3.2.6 Athletes agree to disclose previous classification documentation and/or medical diagnostic documentation from relevant specialists for classification which may include;
 - a) Providing medical diagnostic information detailing the Athlete’s underlying health condition and eligible impairment.
 - b) Undertaking any additional medical assessment or provide further medical diagnostic information as required by AusTri, Paralympics Australia or WT for the purpose of classification
 - c) If an Athlete has any medical intervention, or if changes occur to the Athlete’s impairment which may impact on their classification, Athletes must provide medical documentation to AusTri, Paralympics Australia or WT.
- 3.2.7 Athletes agree to notify AusTri, Paralympics Australia or WT if there is any change to assistive devices, or equipment used, which may impact their classification in any way, and agrees to undergo further classification assessment if required.
- 3.2.8 Athletes have not breached the WT classification rules and regulations, or the IPC Athlete Classification Code, unless the Athlete has been sanctioned for the breach and has completed the sanction imposed (unless the sanction was equal to or greater than 2 years, in which case the Athlete is ineligible for nomination). For purpose of this clause, a breach may include, among other things:
 - a) An Athlete under investigation for International Misrepresentation where a notice has been issued, or the Athlete has been sanctioned under the WT Classification Rules and Regulations; or
 - b) A failure to comply with an Athlete’s obligations under the WT Classification Rules and Regulations.

Part 4: Selection Process for a WTPS Individual Event

4.1. The ESC may select Athletes for nomination to WT for a WTPS individual event via:

- a) Automatic selection; or
- b) Discretionary selection.

4.2. Automatic selection criteria

4.2.1. Subject to Clause 4.2.2, an Athlete may be automatically selected for nomination to WT for a WTPS event if they have a WT ranking in the top two thirds (2/3rds)² (66.67%) of the WT maximum allocation slot of the athlete's respective class as referenced in Table 1 below;

4.2.2. If more Athletes achieve the automatic selection criteria than the athlete quota awarded to AusTri for the WTPS, then only the highest ranked eligible Athlete will be automatically selected, the remaining athletes may be nominated via discretionary selection.

4.2.3. If an Athlete satisfies the automatic selection criteria, they must complete the nomination process in Part 8 of the Policy.

4.2.4. Any remaining positions not nominated via automatic selection may be nominated via discretionary selection.

4.3. Discretionary selection criteria

4.3.1. The ESC may exercise its discretion to select Athletes for nomination to WT. The following criteria must be considered by the ESC when exercising its discretion:

- a) WT Ranking points of the Athlete;
- b) the stage of development as an elite WT Athlete, which will include both the age of the Athlete and their years competing in WT elite para events; with priority given to less experienced elite WT Athletes with positive results progression over experienced elite WT Athletes with limited results progression in the previous 12 months;
- c) probability the event will be beneficial for the WT ranking of the Athlete; with consideration of course profile and anticipated quality of field.
- d) probability the event will be beneficial for the development of the Athlete; with consideration of event timing and location, course profile and anticipated quality of field.

- 4.3.2. Criteria in clause 4.3.1 may be weighted differently, at the discretion of the ESC
- 4.3.3. The criteria must be assessed with reference to the primary objective of the policy in the first instance, but if unlikely to meet the results requirement of the primary objective, the discretionary criteria will be assessed in line with the secondary objective.
- 4.3.4. The discretion of the ESC is absolute. The ESC is not required to make discretionary selections.

Part 5: Selection Process for the PTWCh Individual Event (Pontevedra, Spain)

5.1. The ESC may select Athletes for nomination to WT for the PTWCh individual event via:

- a) Automatic selection; or
- b) Discretionary selection.

5.2. Automatic selection criteria

5.2.1. Subject to Clause 5.2.2, an Athlete may be automatically selected for nomination to WT for a PTWCh event if they have a WT ranking in the top two thirds (2/3rds)⁴ (66.67%) of the WT maximum allocation slot of the athlete's respective class as referenced in Table 2 below;

- 5.2.2. If more Athletes achieve the automatic selection criteria than the athlete quota awarded to AusTri for the PTWCh, then only the highest ranked eligible Athlete will be automatically selected, the remaining athletes may be nominated via discretionary selection.
- 5.2.3. If an Athlete satisfies the automatic selection criteria, they must complete the nomination process in Part 8 of the Policy.
- 5.2.4. Any remaining positions not nominated via automatic selection may be nominated via discretionary selection.

5.3. Discretionary selection criteria

5.3.1. The ESC may exercise its discretion to select Athletes for nomination to WT. The following criteria must be considered by the ESC when exercising its discretion:

- a) the stage of development as an elite WT Athlete, which will include both the age of the Athlete and their years competing in WT elite para events; with priority given to less experienced elite WT Athletes with positive results progression over experienced elite WT Athletes with limited results progression in the previous 12 months;
- b) WT Ranking of the Athlete;
- c) probability the event will be beneficial for the WT ranking of the Athlete; with consideration of course profile and anticipated quality of field.
- d) probability the event will be beneficial for the development of the Athlete; with consideration of event timing and location, course profile and anticipated quality of field

5.3.2. Criteria in clause 5.3.1 may be weighted differently, at the discretion of the ESC

5.3.3. The criteria must be assessed with reference to the primary objective of the policy in the first instance, but if unlikely to meet the results requirement of the primary objective, the discretionary criteria will be assessed in line with the secondary objective.

5.3.4. The discretion of the ESC is absolute. The ESC is not required to make discretionary selections.

Part 6: Selection Process for the Para Team Relay

- 6.1. Athletes must be selected for the individual WTPS event or the PTWCh event to be eligible for selection to the corresponding PTR event
- 6.2. Athletes must use the nomination form and process in Part 8 of the Policy to indicate whether they wish to be considered for the PTR at the respective nominated event.
- 6.3. Selection will be at the discretion of the HPD. This discretion is absolute and need not be exercised. The HPD will consult with a member of the ESC when selecting Athletes for the PTR.
- 6.4. Due to the discretionary selection process for the PTR events, selection may be made prior to the event or at the event. There will be no appeals due to the short time frame.

Part 7: Selection of Guides (for WTPS, PTWCH and PTR)

- 7.1 Once a PTVI Athlete has been selected, the HPD may consider the selection of that Athlete's guide in the HPD's absolute discretion.
- 7.2 In exercising discretion in selecting Athlete's guides, the HPD can consider any matter it deems relevant.
- 7.3 In the event of the withdrawal of a selected PTVI Athlete the selected guide will be automatically withdrawn unless they are subsequently selected to guide a replacement Athlete.
- 7.4 A guide may be changed up to 24 hours before the start of the race. Decisions regarding a change of guide after the announcement of selected Athletes may be made by the HPD.

Part 8: Nomination Process

8.1. AusTri nomination process

- 8.1.1. AusTri HP Operations will call for nominations for WTPS individual events and PTR events from Eligible Athletes 50 days prior to the relevant WTPS event date. This request for nomination will be made via email with an online nomination form.
- 8.1.2. Eligible Athletes have a period of 7 days to submit their nomination to AusTri HP Operations. The nomination period will close at 16:00 AEST on the 7th day after the request for nominations is sent by AusTri HP Operations.
- 8.1.3. Athletes must properly complete all fields in the nomination form to be considered for selection for the event.
- 8.1.4. Acceptance of late nominations is at the absolute discretion of the ESC.

8.2. World Triathlon nomination process

- 8.2.1. AusTri HP Operations must nominate the Athletes selected by the ESC to World Triathlon by the WT race entry deadline via the WT registration system.

8.3. Substitution process

- 8.3.1. Athletes may be selected by the ESC to race events where they cannot secure a place on the start list due to their low WT Para Ranking.
- 8.3.2. The ESC, at its absolute discretion, may direct AusTri HP Operations to use the WT substitution procedure⁶ to facilitate the maximum number of AusTri Athletes on the start list.
- 8.3.3. National federations may replace one Athlete per gender in WTPS events using the WT substitution procedure.
- 8.3.4. Wherever possible, AusTri HP Operations will use the ranking of higher WT ranked AusTri Athletes who have not nominated to race to secure the start place for the lower WT ranked Athlete who has nominated, and who the ESC has selected.
- 8.3.5. The ESC may, at its absolute discretion, use the substitution procedure to replace an Athlete who meets automatic selection criteria with an Athlete selected via discretionary criteria. The lowest ranked Athlete who has met the automatic selection criteria, will be the Athlete whose ranking is used for the substitution procedure. The ESC will only use this power sparingly and must ensure that it aligns with the objectives of the Policy.

Part 9: Selection Outcome and Appeals

9.1. Notification of selection outcome

- 9.1.1. Athletes who have nominated for the event will receive a selection outcome letter via email within 48 hrs of the selection decision.

9.2. Acceptance of selection

- 9.2.1. Athletes selected to be nominated to WT must confirm acceptance of their selection within 48 hours of notification of selection outcome. This must be done by email to HP Operations at admin.hp@triathlon.org.au

9.3. Appeal process

- 9.3.1. Athletes may appeal their non-selection for the individual event in accordance with the [AusTri \(Fast Track\) Appeals Policy](#).

Part 10: Athlete Obligations

10.1. Form and fitness

- 10.1.1. Athletes must declare their race readiness to compete at the time of nomination when completing the nomination form.
- 10.1.2. Athletes not wishing to declare their race readiness to compete on the nomination form and keep their health or injury status confidential must consult with the Chief Medical Officer (**CMO**) during the nomination period.
- 10.1.3. The CMO will determine whether the Athlete is medically fit or likely to be medically fit to compete at the relevant event. The HPD will assess the Athlete's race readiness to compete.
- 10.1.4. Any false declaration on race readiness to compete at the time of nomination, to either the ESC or the CMO, will not be considered favourably by the ESC for future selections.
- 10.1.5. Athletes, once selected to an event or events in the case of those selected via automatic selection, must comply with the [AusTri Form and Fitness Policy](#).

10.2. Non disrepute

- 10.2.1. If an Athlete brings AusTri into disrepute with their behaviour, AusTri at the direction of the CEO may withdraw the Athlete from the event.
- 10.2.2. The ESC, at the direction of the CEO, may refuse to consider the Athlete for selection for nomination to WT for future events.

10.3. Withdrawal from event

- 10.3.1. Nominated Athletes who wish to withdraw from an event within 30 days of an event must notify the HPD. The Athlete must provide reasonable grounds.
- 10.3.2. If an Athlete withdraws within 30 days of the event, it may result in a penalty by World Triathlon to both the Athlete and to AusTri.
- 10.3.3. AusTri may request reimbursement from the Athlete for any costs incurred in booking travel for the event.

Part 11: General

11.1. Amendments

- 11.1.1. The policy may be amended at any time by the ESC if such an amendment is necessary as a result of any change in WT guidelines, or to give effect to the Policy following the discovery of a drafting error or oversight. Any amended policy will be distributed by AusTri by email to all Eligible Athletes and posted on the AusTri website.
- 11.1.2. Should any amendment be required beyond the scope outlined in clause 9.1.1, the Elite Athletes Commission will be consulted, and any amendments will require ratification by the AusTri Board.

11.2. Policy Enquiries

It is the Athlete's responsibility to read and understand the Policy (and other supporting documents and or policies). Queries about the Policy should be directed to the HPD.
